Energy Saving Tips

HEATING

- Turn down your thermostat by 5 degrees to save 25 % on your heating bills.
- Have your furnace professionally cleaned and tuned every year.
- Clean or replace furnace filter every month during heating season.
- Don't block radiators with furniture, drapes, or other objects.
- Open shades during the day to let in sun. Close at night to keep heat inside.
- Lock windows. It tightens the seal to stop heat leaks.

COOLING

 Close shades during day, or plant trees for heat reducing shade.

APPLIANCES

- Water heater temperatures set at 120º- 130º are adequate for most households.
- Install a water-saving showerhead to save \$40 a year.
- A dripping hot water faucet can cost over \$35 a year. Fix it promptly.
- Turn off/unplug appliances that you're not using.
- Keep dryer filters and vents clean. Dirty vents and filters slow air flow and use more energy.
- Don't vent dryers indoors. You add lint and pollutants, along with extra moisture in the air.
- Wash full loads of laundry, using cold water wash and rinse.
